Chapter 17, Appendix F Public Forms- Remove the DFA-NH-RR-1 form now obsolete.

Chapters **17.17, 17.27, 17.32, 17.42, 17.62, 17.72**

This change adds the DFA-MA-1, a shelf document that can only be used to apply for Long term Care (LTC), Aged Disabled Waiver (ADW), Children with Disabilities Community Service Program (CDCSP), (Intellectual Disabilities and Development Disabilities (I/DD), Intermediate Care Facility (ICF), and Traumatic Brain Injury Waiver (TBI).

24.2: was updated to clarify participation requirements.

Chapter 25

25.1: Changed intent of SNAP E&T program to match Federal priorities.

25.2: Changed intent of SNAP E&T program to match Federal priorities. Added maximum number of activity hours. Removed ABAWD language to focus more on voluntary participants.

25.3: Due to Third Party Partners (TPP), expanded language regarding no-cost activities. Removed reference to EIP. Clarified that only non-exempt ABAWDs must meet the 20 hour/week work requirement.
