Preferred Diabetic Supply List (PDSL)

Effective 6/25/2015

The West Virginia Medicaid (Fee for Service) Program established a Preferred Diabetic Supply List on January 1, 2014. (Medicaid Managed Care members will continue to follow their individual plans). Additionally, West Virginia Medicaid (FFS) will no longer pay for diabetes meters. The following products are preferred, along with the meters which will be supplied by Abbott Diabetes Care and Bayer Health Care. Information for billing meters is included at the bottom.
