HCBS Rate Setting Brief



Background

The West Virginia Bureau for Medical Services (BMS) engaged Myers and Stauffer LC (Myers and Stauffer) to review service rates and make recommendations for rate revisions for Home and Community-Based Services (HCBS) provided on the Intellectual/Developmental Disability (IDD) Waiver, following the directives of West Virginia Senate Bill 617. BMS expanded the review to include the Aged and Disabled (AD) Waiver, the Traumatic Brain Injury (TBI) Waiver, and the personal care (PC) state plan service. The rate review and recommendation process included a provider cost survey, significant stakeholder engagement, geographic review, and peer state research.

Cost Reporting Process

- Myers and Stauffer designed and disseminated the WV HCBS cost report, in collaboration with several State and provider community representatives.
- A project website was launched with presentation notes, project timelines and goals, and cost reporting education tools: http://myersandstauffer.com/client-portal/west-virginia/.
- Help-desk support was offered to providers for completing cost reports timely and accurately.
- Fifty-three provider cost report submissions were received from July through September 2023.

Stakeholder Engagement

- Internal stakeholder activities began with BMS in May 2023. External stakeholder activities began in June 2023, with an initial focus on understanding service and service delivery nuances of the IDD, AD, and TBI waivers, or other challenges noted by stakeholders.
- Meetings were held with various BMS program and reimbursement subject matter experts to identify potential issues with rates, service access, or utilization.
- Myers and Stauffer presented in regular policy workgroup meetings with waiver providers.
- Thirty-three scheduled meetings, focus groups, and in-depth interviews were conducted with external stakeholders throughout this initiative.

Rate Build Process

- Data were extracted and analyzed from provider-submitted cost reports.
- With input from BMS, Myers and Stauffer developed rate models¹ for each identified waiver service.
 Models incorporated key cost component values from cost report submissions, national benchmarks, and Bureau of Labor Statistics (BLS) data. A rate model example is provided on the following page.
- Payment and program experts at the State supported the refinement of the rates and helped gather additional stakeholder feedback.

Geographic Adjustment and Peer State Comparison

- Key stakeholders and state program experts identified the Northern Panhandle, Morgantown, and the Eastern Panhandle service areas, as regions in West Virginia with comparably higher workforce costs and increased competition.
- Federal BLS occupational wage data were utilized for service area evaluation.
- Reviews of BLS wage data indicate West Virginia healthcare support occupations for the Northern Panhandle have a positive wage differential between 5-8%, Morgantown 14%, and the Eastern Panhandle 12-15%, respectively.
- County population statistics show these areas account for roughly 26% of the state population.
- Peer state review indicated proposed rates for personal care/attendant care services are on par or exceed surrounding state rates for high utilization service codes.
- Fully funding the proposed rates will result in a sizable increase over current reimbursement rates, likely tempering or negating the need for geographic adjustments.
- It is recommended that BMS monitor the impact of increased rates on member access to services as well as worker pay and turnover rates to determine if the increased rates are having the desired effect on workforce availability and tenure.

Proposed Rates

- Proposed rates for a subset of IDD, AD, and TBI program services are recommended by Myers and Stauffer for consideration by West Virginia.
- The total cost of the proposed rates results in an increase of \$170,572,366.42, including federal and state contributions.
- The primary expenditure increase drivers are the personal care group services (also referred to as personal attendant and person-centered supports).
- IDD waiver last conducted a rate study in 2014 and although the State incorporated temporary rate increases because of ARPA funding, funding adjustments are typically performed every 3-5 years.
